

# The Shaken Baby Alliance 2019

## 52 Week Gun Raffle Rules

1. Ticket purchaser must be a Texas resident, at least 21 years of age, and be able to legally purchase and possess a firearm, including passing a FFL/background check. State and Federal laws apply. Winner must successfully complete "Federal Form 4473" prior to receiving prize. The person whose name is on each ticket will be the only person who can claim the gun won for that ticket. By obtaining a raffle ticket you attest that you are a law-abiding citizen of good moral character, may legally possess the firearm won, agree to use the firearm only in a legal and safe manner, and will, or have already obtained instruction on the safe use and operation of the firearm won.
2. A total of 1000 tickets will be sold at \$100, +.99 service fee, per ticket beginning April 7, 2019 and continuing until all 1,000 tickets have been sold.
  - a. Each ticket will be assigned a three-digit number (between 000 and 999) randomly generated at [www.random.org](http://www.random.org) on 3-29-19 00:52:17 UTC in the order the tickets are sold based on the date/timestamp generated at [www.TicketSpice.com](http://www.TicketSpice.com) at the point payment is processed. This number will be emailed to you within two business days after payment is received at the email provided by the ticket purchaser.
  - b. The winning number will be determined by the results of the Texas Lottery Pick 3 drawing each Monday at 6.00 pm.
  - c. The ticket holder with the assigned number matching the winning Texas Lottery Pick 3 number, in the exact order, will win the gun assigned to that week.
  - d. Drawings will start the Monday following the sale of all 1,000 tickets and will continue for 52 consecutive weeks.
  - e. Guns have been assigned numbers 1-52 and will be dispersed in consecutive weeks in numerical order from 1-52. See gun list here. ([LINK: PDF – 52 Gun Raffle List for Publication](#))
  - f. You keep the same assigned numbers for the 52 consecutive weeks and are eligible to win anytime your numbers are drawn.
  - g. There is no limit on the amount of tickets you may purchase.
3. Winners will be notified, using the contact information (name/phone/email) provided online when purchasing the raffle ticket.
4. Prizes are not transferable. The person designated on the ticket must claim the prize.
5. There are no refunds on ticket purchases.
6. Raffle will not begin until all tickets are sold and will then run for 52 consecutive weeks. Contestants will be notified when the raffle will begin by the contact information provided by contestant. Updates as to ticket sales will be provided via The Shaken Baby Alliance website and/or through The Shaken Baby Alliance social media channels.
7. Firearms can be picked up at Alpine Shooting Range, 5482 Shelby Rd., Fort Worth, TX 76140, or firearm can be transferred to another authorized firearm dealer. Firearm must be claimed within 21 days of the date of the raffle drawing or the winner will forfeit the prize.
8. Prizes are subject to availability. Prizes of equal or greater value will be substituted, if necessary, due to lack of availability. Any pictures of prizes used in promotional activities for this raffle are a good faith effort at representing the prize but may not be an exact representation.
